MOBILE FOOD FACILITY COMMISSARIES

All mobile food facilities (MFFs) and mobile support units must be stored and serviced at an approved commissary when not in use. This requirement is documented through a Commissary Agreement Letter. This document is available at the commissary or you may pick one up from any of our offices.

The following facilities are approved commissaries within Riverside County. A restaurant or other retail food facility, with a valid Environmental Health Permit, may also serve as a commissary. The site must be inspected and evaluated by an Environmental Health Specialist to ensure it meets certain requirements. Commissaries located outside of Riverside County *may* be accepted under certain circumstances, but must be approved by this Department.

The following list may not be complete. Riverside County does not endorse any particular business. The commissary you select will need to meet certain requirements to support your MFF operation. Please contact the commissary to determine if space is available.
