The Riverside County Department of Environmental Health, acting as the Local Enforcement Agency (LEA) is Certified by the Department of Resources, Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites within its jurisdiction. The Burrtec Coachella Recycling Transfer Facility operates under a Registration Permit issued by the LEA on February 13, 2013. The operator filed a certification letter with the LEA. As required by Title 14 Section 18104.2(e), the LEA is distributing this notice for the purpose of notifying its acceptance of the certification letter.

**Description of project:**

The facility is designed to provide direct truck-to-truck transfer of commingled recyclables.

**LEA'S Determination:**

A certification letter was received by the LEA on January 10, 2018. The letter indicates that the current registration permit remains correct and accurate and the operator does not propose any changes at this time. The LEA's determination is to reissue the existing registration permit under the same terms and conditions that are already in place.
